All travelers must possess a valid passport. A \$500.00 nonrefundable deposit per person is due within five days of booking, with final payment due 60 days prior to travel. Payments may be made by check or money order, or by Mastercard, Visa, Amex, or Discover card. Payment in full guarantees your reservation.

Upon receipt of deposit, you will be mailed a confirmation with an invoice for balance due. Tour and flight documents will be sent to you two weeks prior to your departure. Reservations received after the trip closeout date are subject to price increase based on airline and hotel availability. All cancellations must be received in writing. Cancellations received more than 90 days prior to departure will receive a full refund less a \$150 administration fee. Cancellations received 60–45 days prior to departure will receive a full refund, less the \$500 nonrefundable deposit plus any applicable airline cancellation fees. Cancellations received 45–30 days prior to departure are subject to loss of deposit plus applicable airline cancellation fees and hotel cancellation fees. No refunds will be issued after the trip commences.
